



## LEGAL TERMS OF PARTICIPATION IN THE CONTEST

### 1. Organizing Company of the Promotion

The company Artemisa 3000 Tech Solutions SL, identified with CIF number B88466743, organizes this international sweepstakes (hereinafter, "the Promotion") to be conducted through the Internet on its Instagram channel. The purpose of this sweepstakes is to reward participation in our stand and loyalty to our brand.

### 2. Start and End Dates

Participation in the sweepstakes will be open from January 24 to January 26 at 11:59 PM. On January 27, 2024, the winner's name will be announced on our social media channels. The Company reserves the right not to proceed with the promotional action if there are fewer than 20 participants registered by the start date.

### 3. Participation Requirements and Promotion Mechanics

The participation requirements are as follows:

- Individuals over 18 years old are eligible to participate.
- Only those participants who own an Instagram account and follow our Instagram account: @Loverfans, can participate.
- They must have a content creator account on loverfans.com
- The mechanics of the sweepstakes are:
- Each participant must take a photo at our stand at the AVN fair.
- They must upload this image, publicly, on their Instagram account wall.
- The post must mention or tag our platform @Loverfans and use the hashtags designed for this contest #LoverFansAVN and #LoverFansWings.
- Participants can only enter with a single Instagram profile. If a participant is found to use multiple Instagram profiles, they will be disqualified.

### 4. Conditions of the Promotion and Prizes.

The winner will be chosen randomly via the platform app-sorteos.com. The winner will be announced on January 27, 2024, through the brand's social media profiles, along with the validity certificate of the draw.

The prize consists of a \$500 wallet on our Loverfans.com platform.

The winner must contact the Company within 7 days from the date of the announcement on the brand's social profile. If contact is not made within this period, the alternate winner will be contacted.

The conduct of the sweepstakes, as well as the awarding of the prize, is subject to current tax regulations.

#### **5. Disqualifications and Penalties**

If any of the Participants are found not to meet the requirements specified in the Terms, or if the data provided for participation are not valid, their participation will be considered null and they will be automatically excluded from the Promotion, forfeiting any rights to the prize awarded under this Promotion.

The Company reserves the right to declare the sweepstakes void.

#### **6. Publication of Comments and Opinions**

Comments or opinions considered inappropriate, offensive, injurious, discriminatory, or that could infringe upon the rights of others are not allowed. Comments against an individual that violate the rights to honor, personal and family privacy, and one's own image are also not permitted. We are not responsible for any harm caused by comments made by participants in the Promotion that could offend the sensibilities of other participants. Participation in this Promotion and the publication of comments by participants must not violate Instagram's Community Guidelines or Terms of Use under any circumstances. If the Company discovers fraudulent means of participation, such as the use of bots in comments, the prize will not be awarded and will remain the property of the Company.

#### **7. Exemption from Liability**

To be illustrative but not limited, we are not responsible for possible losses, thefts, delays, or any other circumstance attributable to third parties that may affect the development of this Promotion, nor are we responsible for how the participant uses the prize obtained from this Promotion. We do not assume responsibility in cases of force majeure or unforeseeable circumstances that could prevent the execution of the Promotion or the total or partial enjoyment of the prize. In the event that this Promotion cannot be carried out, whether due to detected fraud, technical errors, or any other reason not under the control of the Company that affects the normal development of the Contest, we reserve the right to cancel, modify, or suspend it, including the participation webpage.

#### **8. Personal Data Protection**

In accordance with the General Data Protection Regulation, each participant, by accepting these Legal Terms, consents to their personal data being included in a file owned by the company, for the purpose of managing the sweepstakes, as well as publicizing and advertising its results, and processing the delivery of the prize. You are informed that you can exercise your rights of Access, Rectification, Deletion, Opposition, Limitation of processing, Portability, forgetfulness, and not to be subject to automated individual decisions by sending an email to [rgpd@artemisa3000.com](mailto:rgpd@artemisa3000.com) or by sending a letter to the aforementioned address, attaching a copy of an identification document in both cases. Notwithstanding any other administrative or judicial remedy, the participant has the right to lodge a complaint with a Supervisory Authority,

particularly in the Member State of their habitual residence, place of work, or place of the alleged infringement, if they consider that the processing of their personal data is not compliant with the regulation, as well as in the case of not having their rights satisfied. Therefore, the participant declares to have been informed of the conditions regarding personal data protection, accepting and consenting to the processing.

#### **9. Changes and Acceptance**

We reserve the right to modify or extend these promotional terms, as long as it does not harm or diminish the rights of the Participants in the Promotion. Merely participating in the sweepstakes implies that the participant fully accepts the conditions of these Legal Terms. Furthermore, participation in a sweepstakes of this nature implies acceptance of the rules of the social network Instagram through which it is conducted.

#### **10. Applicable Law and Jurisdiction.**

These legal terms will be governed in accordance with Spanish law. The Courts and Tribunals of the participant's city of residence will have jurisdiction to resolve any claim or controversy that may arise in relation to the validity, interpretation, or compliance with these terms.
